PHILOSOPHY


We believe a strategic perspective paired with periodic rebalancing will result in long-term performance matching or exceeding its benchmark.

- <u>Passive ETF Selection</u> Invest in what we believe are the best possible ETFs that minimize tracking error and cross-correlation, while also delivering maximum overall performance per unit of risk.
- <u>Risk Management</u> By maintaining a portfolio consistent with the desired risk category and rebalancing between growth and value across asset classes; overall reward to risk can be optimized by constructing portfolios on the efficient frontier and rebalancing as necessary to maintain an ever-changing optimal mix of ETFs based on total portfolio risk.
- <u>Consistency</u> Aim to provide investors long term growth along with the knowledge that the CORE portfolios are always fully invested and rebalanced as necessary to manage overall risk.
